PARALEGAL STUDENT ASSOCIATION CAPITOL TOUR

In April, the Paralegal Student Association, along with faculty sponsor Carrie Vaia, toured the newly remodeled Minnesota State Capitol.

During a guided tour that included the Senate and House of Representatives chambers and the Supreme Court courtroom, the students observed the restorations, repairs and updates that were part of the \$310 million preservation effort, which will be completed in 2017.

The newly restored artwork on display throughout the capitol treated the group to vibrant colors and painstaking detailed work, some of which has not been seen in the present condition for over 100 years. The tour began inside the main entrance of the building, where the guide described how Minnesota came to be the home of the second-largest self-supported marble dome in the world.

The group also viewed the Governor's Reception Room and learned the history behind the Civil War paintings on display, depicting some of Minnesota's involvement in the conflict.

After the tour, the group met at the Sawatadee Thai Restaurant in St. Paul for a delicious meal.
