Fees	Rate per Credit	Description
Technology Fee	\$11.14	This fee is used to support student computer labs and other technology that relates to instruction.
Parking/Security Fee	\$3.26	This fee supports the maintenance, snow and ice removal, lighting, and security of the parking lots. Even though all students may not drive, the fee is used to keep the lots in good condition, well lit and secure for all students. This fee is charged up to 15 credits (\$48.90) in Fall and Spring terms, and 8 credits (\$26.08) for Summer term for classes held on campus.
Student Life Fee	\$6.02	This fee is recommended by the Student Life Committee, with the majority of members being students. These funds are used for student activities including but not limited to campus wide events, graduation, recreational activities, art, music, theater, student senate, clubs and organizations.
LeadMN Fee	\$0.35	The LeadMN fee is determined by the Minnesota State College and University Board of Trustees. Funds are used by LeadMN statewide, for activities representing students and to provide training and development of campus leaders.
Student Health Services	\$2.25	The NHCC Student Senate voted during the 2014-2015 academic year to establish this fee. It is used to provide high quality, free or low-cost, wholistic wellness services on campus for students. This is not a fee for health insurance.
Inclusive Access Course Fee	Varies	Instructors can choose to participate in a program designed to help reduce the cost of textbooks. All required materials are available digitally in D2L and an inclusive access fee will be charged to your student account for the cost of these digital course materials in addition to tuition and other fees. This fee may be added to your account thru the first week of the course.
Additional Course Fees	Varies	Some classes such as Music, Exercise Science, Art etc. may have additional course fees. Additional fees are noted on the class description. Seniors citizens that audit classes are required to pay additional course fees.
Credit for Prior Learning	\$80.00	Plus standard fees per credit.
Senior Citizen Fee	\$20.00	MN senior citizens (age 62 or older) registering on a "space available basis" (after the first day of the term) receive a reduced tuition rate of \$20.00/credit. All other fees except the Student Life fee apply. MN senior citizens registering on or before the first day of the term are not eligible for the reduced tuition rate. MN senior citizens are not charged tuition when auditing a credit course or taking a noncredit course when space is available.
